- **4. County Wide Health District-** Councilman Turner moved resolution # 1 of 2010, seconded by Councilman Warren as follows:

Resolution 17 of 2010- Dissolving the Town Wide Health District In Favor of the County Wide Health District

Whereas, St. Lawrence County, with the approval of the New York State Commissioner of Health has established a county wide health district pursuant to Public Health Law Sect. 340, and

Whereas, the Town board of the Town of Morristown has determined that it is no longer desirable for the Town to maintain a local health district after the establishment of the county wide district,

Now Therefore Be It Resolved, pursuant to paragraph 3 of Section 341 of the Public Health Law that the Town of Morristown does hereby dissolve the local health district of the Town of Morristown, and

Be It Further Resolved, that pursuant to paragraph 3 of Section 341 of the Public Health Law, all the powers and duties of the local board of health of the local health district of the Town of Morristown shall devolve upon the board of health of the St. Lawrence County county- wide health district and all the powers and duties of the local health officer of the local health district of the Town of Morristown shall devolve upon the St. Lawrence County county health director. - 1. Cancer Action-Don Hassig stated that the Town of Pierrepont has a local law prohibiting the dumping or burying of waste town wide. Stated that buried waste leaches toxins into the water supply. He asked the Town to enact a similar law. The question of enforcement was discussed. Also presented concerns with air quality due to Canadian chemical plants on the North shore of the Saint Lawrence River. Asked the town to contact DEC and ask them to put a monitoring station up here to check on air quality.
