Old Business

- 1. Village Dissolution Planning
 - **a.** Comprehensive Plan 2019: The public was informed that a public meeting will be held on Tuesday, November 27th at the Morristown Fire Hall to explain the process and gather public comment and ideas on the future of Morristown.
- 2. 2019 Budget: The Board agreed they were ready to approve the 2019 Budget as presented. As the first order of business unpaid sewer charges needed to be re-levied to the 2019 Town tax warrant. A motion was made by Councilman Turner to move Resolution 15 of 2018 as follows: Resolution # 15 of 2018 Sewer Re-Levy Authorization for the 2019 Budget

Be It Resolved, that the Town Board of the Town of Morristown authorizes the re-levy of all unpaid 2018 sewer bills from Sewer District #1, in the amount of \$12,337.50 and authorizes the re-levy of all unpaid 2018 sewer bills from Sewer District #2, in the amount of \$8,865.40, for a total re-levy of 21,202.90, to the 2019 Town Tax Warrant. The Motion to adopt was seconded by Councilman Coffin.

New Business

1. Gateway Museum: Susan Shelato spoke to the Board on behalf of the Gateway Museum about new signs for the Village showcasing popular attractions. The Boat Launch, Stone Library, Stone Windmill, Gateway Museum and Red Barn Nature Preserve will be highlighted. The Museum will raise the funds for the new signs. They asked for assistance in putting them up on the existing sign frames. The Board advised them to make sure and check with the NYS DOT on the sign on State Highway 37 before spending time and money on the project. Dean Shelato thanked the Board for its support and assistance with the nature trail and boardwalk at the Red Barn Preserve. The Gateway Museum had record attendance at the museum to visit their new major exhibit. Visitation to the Blue Heron Trail at the Red Barn Preserve has been beyond expectation. Mr. Shelato will be applying for more grants and asked the Board if the Town would be lead agency for a St. Lawrence River Valley Redevelopment Grant should the application be successful. The Board indicated that they would be pleased to do that for the museum. Mr. Shelato also asked if the Highway Department would assist in building a second Board walk for a new trail.

Resolution #14-Life Flight: A motion was made by Councilman VanArnam, and seconded by Councilman Macaulay to adopt Resolution #14 of 2018 Life Flight Resolution as follows:

Resolution #14 of 2018 Life Flight

WHEREAS: North Country Life Flight, Inc. is a not for profit, tax exempt corporation which is responsible for all aspects of patient care by providing medical equipment, training, medical personnel and administering the medical portion utilizing the New York State Police helicopter based in Saranac Lake and private fixed wing aviation resources, and,

WHEREAS: The New York State Police aviation resources do not provide a medically trained team or medical equipment for patient transports; and

WHEREAS: The people of Clinton, Essex, Franklin, Hamilton and St. Lawrence Counties receive a vital emergency medical service which is free of charge to critically ill and seriously injured patients, and, therefore municipal governments are asked to pledge monies for this worthwhile program;

NOW, THEREFORE, BE IT RESOLVED: That the Town Board of the **Town of Morristown** hereby authorizes the Supervisor to enter into a contract with North Country Life Flight, Inc. for the purpose of operating the medical component of the Medivac program, which will serve its residents and visitors, and paying the amount of \$150.00, which represents the Towns share for 2019; and be it

FURTHER RESOLVED: That the sum of \$150.00 is hereby appropriated to account No. B -4989.4 for payment to North Country Life Flight, Inc.
