Swimming Lessons – **5 to 12 year olds – Tuesday, Wednesday and Thursday starting July 9th to August 1st from 1:00 to 3:00 at Keewaydin State Park.** Pickup locations will be at Morristown Central School at noon, in front of the Brier Hill Fire station in their parking lot at 12:10PM, and at Hammond Central School at 12:30PM. The bus will be return to Hammond Central School at 3:30PM, Brier Hill Fire Station at 3:45PM and Morristown Central School at 4:00PM. **Children who do not have a ride waiting for them twice will no longer be able to participate.**

Children need to attend swimming lessons wearing their swimsuits and appropriate footwear, and should bring a towel, snack and/or drink for out of the water times. Children can bring a labeled life preserver to use at the park. All swim lessons are subject to weather cancellations. **It is very important to list valid contact numbers in case of cancellations.** If swimming lessons are cancelled, children will be returned to their respective drop off sites. The last week there will be a pizza party at Keewaydin.
